

## Admission Appeals Timetable

## Secondary School

- Secondary School Allocation Day Friday 1st March 2024.
- Deadline for Receipt of a Secondary School Admission Appeal Form Tuesday 16<sup>th</sup> April 2024.
- Secondary School Admission Appeals will be held at a date to be confirmed within 40 school days of deadline to lodge appeal and will be held between Tuesday 7th May 2024 and Wednesday 19<sup>th</sup> June 2024.
- Notification of appeal hearing date At least 10 school days before the appeal hearing.
- Deadline for the Admission Authority to submit their case papers to the Clerk to the Independent Appeals Panel At least 9 working days before the date of the appeal hearing.
- Clerk to send appeal papers to Appellants, Panel and the Admission Authority – At least 7 working days before the date of the appeal hearing.
- Deadline to submit additional information to the Clerk to the Independent Appeals Panel – At least 3 days prior to your appeal date.
- Decision Letter sent to appellants and Admission Authority within 5 school days of the decision being made.

## **Primary School**

- Primary School Allocation Day Tuesday 16th April 2024.
- Deadline for Receipt of a Primary School Admission Appeal Form Thursday 16<sup>th</sup> May 2024.
- Primary School Admission Appeals will be held at a date to be confirmed within 40 school days of deadline to lodge appeal and will be held between Wednesday 12<sup>th</sup> June 2024 and Thursday 18<sup>th</sup> July 2024.
- Notification of appeal hearing date At least 10 school days before the appeal hearing.
- Deadline for the Admission Authority to submit their case papers to the Clerk to the Independent Appeals Panel At least 9 working days before the date of the appeal hearing.



- Clerk to send appeal papers to Appellants, Panel and the Admission Authority – At least 7 working days before the date of the appeal hearing.
- Deadline to submit additional information to the clerk to the Independent Appeal Panel – At least 3 days prior to your appeal date.
- Decision Letter sent to appellants and Admission Authority within 5 school days of the decision being made.

## In Year Appeals

- Deadline for Receipt of an In Year Admission Appeal Form appeals can be submitted within the academic year for which the in-year application had been submitted.
- In Year Appeals will be held within 30 school days of the appeal being lodged.
- Notification of Appeal Hearing date At least 10 school days before the appeal hearing.
- Deadline for the Admission Authority to submit their case papers to the clerk to the Independent Appeals Panel At least 9 working days before the date of the appeal hearing.
- Clerk to send appeal papers to Appellants, Panel and the Admission Authority – At least 7 working days before the date of the appeal hearing.
- Deadline to submit additional information to the Clerk to the Independent Appeal panel At least 3 days prior to your appeal date.
- Decision Letter sent to appellants and Admission Authority within 5 school days of the decision being made (usually within one school day of the decision being made).
